#### Report, Discussion, and Possible Action on Personnel Changes, Impact on Current Service Level, and 5. Implementation of a Service Level Reduction

Chief Thompson provided the Board with an update on staffing levels. With two full time firefighters tending their resignation, the department is no longer able to effectively staff both stations seven days a week with an engine company. Service levels will be reduced to five personnel per day to provide coverage on the brush patrol and one engine. Chief Thompson proposed to close operations at Station 422 effective June 1, 2013. The station will still host CPR and certification training classes.

Having no other viable alternative, it was the consensus of the Board to move forward with the closure of Station 422.

  - 8.1 Fire Chief's Report

Chief Thompson reported the Department responded to 187 calls for assistance during March. The Annual Easter Egg Hunt was a success. Annual school inspections are ongoing. The Citizen's Advisory Committee met on April 10, 2013. Several ideas were proposed and are being researched. The Committee will be meeting again on May 8, 2013, at 6:00 pm. Meetings are open to the public.

8.2 Finance Report

Ms. Byerrum, Financial Consultant, reported that the deficit is larger than what was budgeted but will be offset somewhat by property tax assessments.

> Director Chambers stated that with deficit spending and without an inflation adjuster, service levels have to be cut. He advised citizens to attend the Advisory Committee meetings and get involved.

> Director Shinaver would like to see fire calls in the newspaper again. Director Cisneros advised Chief Thompson to do the best he can with the resources he has.
