PRESENTATION AND DISCUSSION OF LEGISLATIVE POLICY

PRIORITIES FOR 2019

BACKGROUND AND DISCUSSION

Last year, the Board of Directors (Board) adopted policy principles directing the establishment of positions and actions on legislative and regulatory issues.

The policy principles, as adopted by the Board focus on: (1) ensuring the District maintains its ability to raise revenues for local challenges while maintaining affordable water rates; (2) that funds collected through any new funding laws return to the region in the form of grants; and (3) that all legislation and regulations proposed account for the district's weather, water source, and demographic characteristics.

On Friday, October 12, the District's legislative and regulatory affairs committee convened and with the input of staff and consultants, outlined the following priorities for the Board's consideration.

Recommended Public Policy Priorities for 2019

- 1) Funding: California voters approved Proposition 68, the Parks, Environment, and Water Bond, authorizing \$1.27 billion (of \$4.1 billion) to be allocated to drinking water treatment, groundwater clean-up and flood protection. Proposition 3, the Water Supply and Water Quality Act, will appear on the November ballot. If passed, Proposition 3 will authorize \$8.877 in spending for various infrastructure projects, including \$750 million for drinking water projects that benefit disadvantaged communities. Together, the two funding measures, and the District's current grant application, present funding opportunities to address the District's needs.
- 2) Drought: On May 31, 2018, Governor Brown signed AB 1668(Friedman) and SB 606 (Hertzberg) into law. Together, the bills implement new water use efficiency requirements for urban water suppliers (3,000 or more connections or deliver more than 3,000 acre-feet of water). The State Water Resources Control Board (State Water Board) and the Department of Water Resources

(DWR) have provided guidelines for implementing the laws. On October 12, the District submitted a nomination form to serve on the Urban Advisory Group to inform the laws' implementation and ensure the State Water Board and DWR accounts for the region's environmental characteristics in establishing new conservation measures.

- 3) Water Quality: In 2017, the State Water Board remanded the maximum contaminant level (MCL) for Hexavalent Chromium (Cr6) due to a court ruling issued in the case of California Manufacturers & Technology Association, et.al. v. State Water Resources Control Board. In the ruling, the court ruled that the Department of Public Health (DPH) failed to consider economic feasibility when, in early May 2014, it set the nation's first drinking water standard in California for Cr6 at a MCL of 10 parts per billion (ppb). The judge ordered the State Water Board to withdraw the 10ppb MCL and establish a new MCL that takes into account the true economic impacts to water systems. The State Water Board is in the process of finalizing its first draft of economic feasibility guidelines to be utilized in the establishment of a revised MCL for Cr6 and other contaminants. A draft of the guidelines for public comment is expected in early November 2018.
- 4) Water Affordability: The State Water Board developed a stakeholder group comprised of various stakeholders, including Consultant Adan Ortega, to provide input on the development of the state's first Low Income Water Rate Assistance Program as mandated by the passage of AB 401. The State Water Board's original deadline for completing its report to the legislature on the implementation of the program was February 2018; the report is expected by the end of the year. In addition to the low-income water rate assistance program, the legislature considered passage of the state's first tax on water through SB 623 (Monning) and subsequently, SB 845 (Monning). Both bills intended to establish a monthly per meter fee to fund safe drinking water for disadvantaged communities. The sponsors of the legislation, the Community Water Center - a Central Valley based non-profit organization - proposed the legislation as a solution to solving drinking water issues in that specific region; with no guarantee that the funds generated by the new program would have returned to Twentynine Palms or any other disadvantaged community outside of the Central Valley. The District was successful in opposing the legislation. Following the elimination of the bill's advancement, Assembly Speaker Anthony Rendon released a statement expressing his commitment to identifying solutions to the state's drinking water issues; adding that Assemblyman Eduardo Garcia (D-Coachella) and Heath Flora (R-Oakdale) will lead the Assembly's efforts on the matter.

2019 marks the beginning of the legislature's two-year session, and the first year of a new Administration. The results of the November election will have significant impacts on the legislature's actions next year. Those issues, coupled with new leadership at the State Water Board, will require the District's continued engagement on legislative and regulatory issues regionally and statewide

RECOMMENDATION

The legislative and regulatory affairs committee recommends that the Board of Directors approve the 2019 Public Policy Priorities for the District.

BACKGROUND AND DISCUSSION

At the July 25, 2018 the Board of Directors discussed the current mainline extension policy that requires mainline to traverse one complete side of a property when infrastructure is needed to provide water to a property.

Through discussion it was determined that a policy change was desired to conform to past practices and to increase the flexibility to the construction of new distribution pipeline requirements for the customer and District.

The resolution prepared for review and consideration to adopt tonight reflects the changes and recommendations that were discussed.

RECOMMENDATION

Adopt Resolution 18-14 Revising The Policy For Mainline Extensions.

RESOLUTION NO. 18-14

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE TWENTYNINE PALMS WATER DISTRICT REVISING THE POLICY FOR MAINLINE EXTENSIONS

WHEREAS, the Board of Directors ("Board") previously adopted a policy requiring distribution pipelines to traverse one complete side of a property requiring new, enlarged, and/or expanded service connections ("Policy"). That Policy was established pursuant to District Resolution No. 03-15. The Policy is currently set forth in Twentynine Palms Water District Code, Section 7.05.030(3)(b); and

WHEREAS, the Policy is, for many reasons, not feasible to implement, and the Board has, on occasion, allowed the construction of distribution pipelines to the corner of a property requiring new, enlarged, and/or expanded service connections, rather than across one complete side of a property; and

WHEREAS, the Board desires to revise the Policy in conformance with past practices and to increase the flexibility regarding the construction of new distribution pipelines consistent with the best interests of the District and its customers such that distribution pipelines for property requiring new, enlarged, and/or expanded service connections may be constructed to the property corner and will only have to traverse an entire property side when additional infrastructure is needed to meet fire flow or other legal requirements.

NOW, THEREFORE, the Board of Directors does hereby RESOLVE and ORDER as follows:

- Section 1: Section 7.05.030(3)(b) Capital impact fees Policy of the Twentynine Palms Water District Code is hereby amended as follows:
 - (b) Secondary. All new, enlarged and/or expanded service connections shall be charged a secondary capital impact fee (SCIF). The amount of this SCIF shall be equal to the greater of:
 - (i) The actual cost to provide the required secondary infrastructure; or
 - (ii) A calculated fee that is based on the linear footage of the property requiring new and/or enlarged/expanded service.

Actual cost shall include, but is not limited to, the cost of fire hydrants and/or a distribution pipeline. Actual cost shall be charged when there is no or only partial secondary infrastructure available to the required service or when there is inadequate capacity in the existing system to provide the required water flow for the new or expanded service. Actual cost may include the cost of new and/or enlarged/expanded secondary infrastructure. If fire hydrants and/or a distribution pipeline are required, the SCIF shall be based on the cost of extending the existing distribution system in such a manner that the resulting expanded

distribution pipeline traverses at least one complete side of the property requiring water service only if fire flow or other legal requirements so mandate; otherwise, the expanded distribution pipeline may be constructed to the property corner. Property that has participated in the annexation of Assessment District No. 4, and has not been subsequently subdivided, shall not be required to extend a required distribution pipeline in such a manner that the resulting expanded pipeline traverses one side of the property. However, property that participated in Assessment District No. 4 and that was subsequently subdivided shall be subject to the requirement of having secondary infrastructure traverse one complete side of the property only if fire flow or other legal requirements so mandate; otherwise, the secondary distribution pipeline may be constructed to the property corner. Further, property that has participated in the annexation of Assessment District No. 4 shall only be subject to the actual cost to provide the additional required secondary infrastructure to the property and shall not be subject to a calculated fee if adequate secondary infrastructure already exists.

The calculated fee shall be based on the linear footage of the frontage of the subject property times \$6.00 per foot. Frontage is defined as the side of the property to which the property address has been assigned by the city or county.

If the subject parcel currently has water service, no calculated fee will be charged for impact on the secondary infrastructure. The new and/or enlarged/expanded service is however obligated to pay for the actual cost of upgrading the distribution pipeline to provide the required additional water flow. No credit will be given for an existing pipeline that is to be replaced with a larger one.

Section 2: The Policy contained in Resolution 03-15 and all other related actions are hereby superseded to the extent they are inconsistent with this Resolution modifying the District's Policy. Resolution 03-15 otherwise remains valid and in full force and effect.

Section 3: If any provision in this Resolution or the application thereof to any person or circumstances is for any reason held invalid, the validity of the remainder of this Resolution or the application of such provisions to other persons or circumstances shall not be affected thereby. The Board hereby declares that it would have passed this Resolution and each provision thereof, irrespective of the fact that one or more sections, subsections, sentences, clauses, or phrases or the application thereof to any person or circumstance be held invalid.

Section 4: This Resolution shall become effective upon the date of adoption as set forth herein.

Section 5: The Recitals set forth above are incorporated herein and made an operative part of this Resolution.

BACKGROUND AND DISCUSSION

The District is required to review our Conflict of Interest Code (Code) every two years and make changes to the Code if necessary to meet legal requirements. Once the Board approves and adopts the amended Code the District will file a Local Agency Biennial Notice with the County Board of Supervisors notifying them of the adopted changes.

This year there were amendments made to the Code due to the organizational changes that took place this year related to the reclassification of a position and the creation of a new positon within the organizational structure of the District.

RECOMMENDATION

Adopt Resolution 18-15 Amending the Twentynine Palms Water Districts Conflict of Interest Code.

RESOLUTION NO. 18-15

RESOLUTION OF THE BOARD OF DIRECTORS OF THE TWENTYNINE PALMS WATER DISTRICT AMENDING THE CONFLICT OF INTEREST CODE PURSUANT TO THE POLITICAL REFORM ACT OF 1974

WHEREAS, the State of California enacted the Political Reform Act of 1974, Government Code Section 81000 et seq. (the "Act"), which contains provisions relating to conflicts of interest which potentially affect all officers, employees and consultants of the Twentynine Palms Water District (the "District") and requires all public agencies to adopt and promulgate a Conflict of Interest Code; and

WHEREAS, the Board of Directors adopted a Conflict of Interest Code (the "Code") for the District which was amended on September 27, 2006, in compliance with the Act; and

WHEREAS, subsequent changed circumstances within the District have made it advisable and necessary pursuant to Sections 87306 and 87307 of the Act to amend and update the District's Code; and

WHEREAS, the potential penalties for violation of the provisions of the Act are substantial and may include criminal and civil liability, as well as equitable relief which could result in the District being restrained or prevented from acting in cases where the provisions of the Act may have been violated; and

WHEREAS, notice of the time and place of a public meeting on, and of consideration by the Board of Directors of, the proposed amended Code was provided each affected designated position and publicly posted for review at the County Administrative Offices at 4080 Lemon Street, Riverside, California; and

WHEREAS, a public meeting was held upon the proposed amended Code at a regular meeting of the Board of Directors of the District on October 24, 2018, at which all present were given an opportunity to be heard on the proposed amended Code.

NOW, **THEREFORE**, **BE IT RESOLVED** by the Board of Directors of the Twentynine Palms Water District as follows:

Section 1. The Board of Directors does hereby adopt the proposed amended Conflict of Interest Code, a copy of which is attached hereto and shall be on file with the District Secretary and available to the public for inspection and copying during regular business hours.

Section 2. The said amended Code shall be submitted to the Board of Supervisors of the County of San Bernardino for approval.

Section 3. The said amended Code shall become effective immediately upon approval by the San Bernardino County Board of Supervisors.

<u>Category 5</u>: All investments and business positions in business entities, and sources of income, including gifts, loans and travel payments, that provide services, products, materials, machinery, vehicles or equipment of a type purchased or leased by the designated position's department, unit or division.

BACKGROUND AND DISCUSSION

The District operates a 3 million gallon per day (MGD) Fluoride Removal Treatment Plant (Plant) that is supplied water from well TP-1, a single source water well for the Plant. There are operational challenges to only having one well provide water to the Plant that in the case of TP-1 is experiencing mechanical issues or failure, the Plant would not be able to produce water.

Over the years the District has shut down several water wells due to unfunded regulations which has resulted in the shift of water production to the Mesquite Springs sub-basin. The water extracted from this sub-basin is treated to remove high naturally occurring fluoride to meet State standards. During the higher demand water production months the water being produced from the Plant is a critical component to maintaining adequate water supply for the distribution system.

Back in 2015 the District submitted a grant application seeking funding to start the process of designing and engineering of the secondary water well for the Plant which is referred to as TP-2. This additional well will establish redundancy for the Plant. As of the yet, the District has not been contacted with any decision related to the grant application. It is important that the District moves forward with this priority project to ensure the ability to meet water demands of the distribution system.

Staff has requested Engineering Resources of Southern California to provide a proposal for engineering services to develop specifications and design of well TP-2. The proposal is attached for your review.

FISCAL IMPACT

The current fiscal year budget has \$1.2M allocated for design and construction of TP-2.

RECOMMENDATION

Staff recommends to accept the proposal from Engineering Resources of Southern California to provide engineering services for TP-2 in the amount of \$74,100.00

SUBJECT: CONSTRUCTION AND EQUIPPING OF WELL TP-2

Dear Ray:

In response to the District's invitation, *Engineering Resources of Southern California*, *Inc.* (*ERSC*) hereby submits our proposal concerning construction and equipping of Well TP-2. In general, the services will consist of preparation of plans, specifications, and estimates (PS&E) for construction and equipping of the well and assistance during the bid period. Details of these tasks and services follows.

PROJECT UNDERSTANDING

From our discussions with the District, it is our understanding that Well TP-2 will be a backup or alternative to Well TP-1 to feed the District's fluoride removal treatment plant and the wells will not be operated simultaneously. Well TP-2 will likely be approximately 500-600 feet northwest of Well TP-1 on the same 160-acre parcel and be of the same size, depth, and intended production capacity of about 885 gpm. It is also my understanding that the District may want the new well located within the existing fenced and bermed area.

We are aware that the site is subject to flooding and that the wellhead therefore will need to be elevated above the 100-year frequency flood level as for TP-1, elevation +/-1823, and other features on the site. Additionally, wellhead will be enclosed in a building which by necessity will need to have overhead access via a skylight or hatch to allow removal of the pumping equipment. Additionally, the roof and portions of the building walls will need to be removable to allow access for maintenance of the well itself when needed for bailing, brushing et al. Due to the raised wellhead elevation a ramp will therefore be required to provide access for maintenance equipment to the wellhead. Elevation of the aforementioned features and designated well site will need to be verified by survey.

After construction of the well is complete, Well TP-2 will be equipped with a vertical turbine pump assembly with delivery and discharge to the existing fluoride treatment plant. It is assumed that the District will be responsible for design and installation of the discharge piping beyond the wellhead.



It is our understanding that the District will contract separately with Hydrogeologist Mark Roberts for well site selection and with another firm for preparation of environmental review and necessary documents.

Provided and to be used is topo of the site provided by the District's engineering consultant responsible for design of the third evaporation pond supplemented with limited additional survey. Indicated are elevations of the first two pond berms and that of the plant which were set above flood level at elevations of 1811 to 1812 respectively per the topo map received. Flood level for Well TP-2 will be higher as it is upstream and closer to Well TP-1.

SCOPE OF PROPOSED SERVICES

Proposed services will include design engineering services by *ERSC* assisted by Mark Roberts, Consulting Hydrogeologist, concerning well design, and geotechnical and survey subconsultants. Services, therefore, will include the following tasks to provide documents to the District suitable for bid solicitation for construction and equipping of Well TP-2.

- 1. Review project scope and budget; project management and coordination with the District.
- 2. By means of a subconsultant survey firm conduct limited topo survey of the well site selected by the District. Envisioned is procurement of the designated well site elevation and a number of points within 50 to 100 feet for purposes of preparation of the grading plan required, and verification of the floor elevation of Well TP-1, all related to the elevation datum of the provided topo map. Well TP-2 wellhead will be set above the 100-year flood elevation determined for the actual well site.
- 3. Research potential 100-yr flood level on the parcel for selected well site to guide elevation design of the wellhead structure.
- 4. By means of a geotechnical consultant conduct a site investigation of the selected well site to determine foundation preparation requirements for the elevated foundation construction. Proposal of the firm Landmark Consultants, Inc. accompanies.
- 5. Retain and utilize Consulting Hydrogeologist, Mark Roberts, to advise regarding the well construction specifications and details. His proposal accompanies this letter.
- 6. Prepare design for Well TP-2 construction which will be very similar to that used for Well 11B, though only stainless-steel casing material will be specified, as desired by the District. Plan will include wellhead construction details and provision for elevation above flood level.

- 7. Prepare design and plan(s) for equipping of Well TP-2, for a discharge of ±885 gpm to the District's treatment plant. Plans will include well discharge and pump to waste piping outlets from an elevated site.
- 8. Prepare grading and structure support plan(s) for the elevated wellhead including access for maintenance.
- 9. Assist in preparation of the CEQA document be providing information requested.
- 10. Also, to be researched and designed is a building enclosure. Required is access to the wellhead as described previously. To be determined are building materials and construction suitable to accommodate the pumping equipment removal and maintenance of the well itself. We will consult with you and conduct research to determine possible building options and costs to present for your consideration. Upon selection specifications will be prepared. Required and to be included will be determination of method of support for the building whether earth only or supplemented by structural walls and of appurtenances for the building to provide for entry, lighting ventilation and "housekeeping". Scour protection of the elevated site needs to be considered also. We propose to conduct this research and design as a separate task with an estimated fee as we do not sufficiently know scope of services required.
- 11. Design and PS&E for electrical service from the existing Well TP-1 motor control center will be completed by Mike Milam of Doby Engineering who prepared similar services for the District's Well Nos. 12, 17 and 11B. Proposal accompanies. You have indicated that the motor control for the well will not be sited within the wellhead building.
- 12. Prepare specification document for the well construction, equipping, discharge piping and grading/structures required.
- 13. Prepare quantity and cost estimates.
- 14. Plans, specifications and estimate will be submitted for review at approximately the 90% completion stage and final for approval by the General Manager.
- 15. Coordinate and make submittals to the State Water Resources Control Board Division of Drinking Water for review and to alert the Division of the well construction project.

- 16. Provide bid period assistance as desired or requested including the following:
 - a. Reproduce plans and specifications for distribution to bidders from the District and from ERSC offices, if desired.
 - b. Respond to questions and issue clarifying addenda, if needed.
 - c. Attend bid opening, if requested.
 - d. Review bids and make award recommendation.

ENGINEERING FEE

ERSC proposes to complete the services described above for the following amounts.

- 1. Design and preparation of PS&E documents for well construction and equipping, and grading plan, Task Nos. 1 through 9 and 11 to 15, will be conducted for a lump sum amount of \$65,000.
- a. Research, selection of a suitable building, design of appurtenances and structural support if required and preparation of specifications, defined in Task No. 10 will be conducted on Time & Materials basis, with reimbursement per the accompanying Schedule of Hourly Billing Rates. Estimated amount for these services is \$6,100.
- 2. Compensation for Task No. 16, Bid Assistance, will be on a time and materials basis with an estimated amount of \$3,000. Services and fees are dependent upon the effort requested by the District.

GRANT FOR DISTRICT'S AMI/AMR SMART METER PROJECT

BACKGROUND AND DISCUSSION

In April of 2018 the District submitted an application to the Bureau of Reclamation (BOR) seeking funding opportunities for the District's AMI/AMR meter project. The District was seeking up to \$1M dollars for this project with a matching fund element.

On Tuesday October 2, 2018 I was notified by the BOR that the District's application will not be considered for funding due to the project not receiving a high ranking among the 127 applications that were received. The letter from the BOR is enclosed for the Board's review.

District staff will evaluate options to consider for funding of this project. These options may include debt financing, using reserve funds to fund the project or use a phased approach to installing AMI/AMR meter infrastructure using available funds in the annual budget in the CIP project list.
